**II. OPEN SPACE SUB-COMMITTEE**

**A. PROPERTY UPDATES**

**1. Dravecz Parcel – Apple Street**

Mr. Beardsley said Mrs. Yerger was going to ask Chris Garges about the acreage. Mrs. Yerger said she did ask him and he thought it was the same, but she will remind him again. She said Mr. Garges said the lot lines are correct. Mr. Beardsley said he needs more direction and he thinks we need to talk to Parks & Recreation to see if they are interested in doing anything there. Mrs. Yerger said she will speak to Leslie and see if we want to approach Parks & Recreation to see if they are interested. Mr. Beardsley said if they are, he would go out and speak to Mrs. Dravecz again along with a Parks & Recreation member.

**B. OPEN SPACE EDUCATIONAL MATERIALS**

Mr. Carocci said Ms. Stanlick, Mr. Germanoski, Mr. Jauregui and himself worked on a flyer for land preservation and open space in Lower Saucon Township for the open space referendum on November 8, 2016. Mrs. Yerger said this is just for our education as a board. We will not be advocating this. This is just so we are aware of it.

Mr. Carocci said there is a Facebook site where residents can upload a copy of the flyer. It's called Lower Saucon Citizens for Open Space. Mr. Carocci, along with some other EAC members said they will be passing the flyers out, as residents. The EAC made some changes on the brochure and Ms. Stanlick said she will prepare it and it should be finalized by Friday. Mr. Boyle said he will make copies of the brochure.

Mrs. Yerger said as part of the question being asked on the ballot regards Polk Valley Park. That was purchased before we had any EIT in the Township, so that's why they floated a loan and it was a substantial loan for that park. Mr. Carocci said with the presidential election, there will a lot more people coming to vote. He asked can we put it on the ballot next year if it doesn't pass. Mrs. Yerger said it's part of the state enactment and she doesn't think you can. You have to wait. She said Williams Township lost last year by four votes and they had passed it two times before.

Mr. Carocci said it's very important to talk to your neighbors and friends. They will pass the flyers out at polling places and see if they can get some people to help them.

Mrs. Yerger said we have crunched the numbers on what it would potentially save the Township by paying off the loan for Polk Valley Park. A lot of people use it and don't want it to go away. It will save them minimally \$200,000.00 in interest alone by clearing that off. The Dog Park is also so popular.

Mr. Beardsley said we need to get a list of people who got conservation easements and give them a couple dozen flyers to hand out as they benefitted from the conservation easements.

Mr. Carocci said everyone should let him know how many copies everyone handed out so he can keep count of them. Mrs. Yerger said we could say because of this, we garnered how many million dollars from DCNR as well as the state and the county. Woodland Hills we got close to \$1 million in funding for that piece of land. She will try to get dollar figures from Cathy Gorman.

Mrs. Palik said Northampton County is looking for places to have the latex based paint event for 2017. Mrs. Yerger said do we want to have this? Ms. Palik said she will get some information from FreeCycle and AERC.

**MOTION BY:** Mr. Hijazi moved to recommend to Council that the EAC would like to host a 2017 Latex-Based Paint event at the Township, per the email from Kenneth Zinis from Northampton County asking for collection sites. Lower Saucon Township participated in 2015 and it was a very successful event.
