Mrs. Yerger said Council did meet in Executive Session this evening to discuss a personnel item that will be discussed during the meeting.

**A. RESOLUTION #30-2018 – HONORING RONALD HORISZNY FOR HIS DEDICATED SERVICE**

**III. DEVELOPER ITEMS**

**A. SILVER LAND, LLC/SILVER CREEK COUNTRY CLUB – 700 LINDEN AVENUE, HELLERTOWN – REQUEST APPROVAL OF HELLERTOWN BOROUGH AUTHORITY TO PROVIDE WATER & SEWER FOR THE PROJECT (7:12 p.m.)**

Attorney Jim Preston was present representing Silver Land, LLC. They want to make sure they have water and sewer service at the site through Hellertown Borough Authority (HBA) and would like Council's approval; they will also need an agreement. The EDU's will be through HBA, and Attorney Treadwell said the agreement, which will be brought back to Council, will be limited to the project and the number of EDU's associated with that project. They met with Attorney Preston, Silver Land, HBA, and Lower Saucon Authority (LSA), and it was agreed that HBA was best suited to serve the project.

IV. **TOWNSHIP BUSINESS ITEMS**

A. **ZONING HEARING BOARD VARIANCES**

1. **DAVID & TRACY D'AGOSTINO – 1530 HIGHLAND DRIVE – VARIANCE REQUESTS FOR ZONING VIOLATIONS ASSOCIATED WITH CONSTRUCTION OF POOL (7:19 p.m.)**

Mr. Gavin Laboski representing the D'Agostino's was present. They were previously before Council in July and October and the engineer proposed some storm water management facilities to be installed; those remain a part of this proposal. Mr. Paine from Paine Custom Pools put the plans together which show a reduction in impervious surface coverage. There are two options, one requiring 5% relief and one requiring 2.5% relief.

Mr. Kocher said combining the proposal with the storm water plan talked about previously, should be fine from a storm water aspect. They would need to see it together on a plan with back-up calculations and would like to see how the storm water gets into those beds.

Attorney Treadwell said that since a motion was passed previously opposing it, we need a motion based on both plans being presented at the ZHB and the Township Engineer receiving what he needs regarding the storm water.

2. **ROBERT & MARGARET KELLY – 1596 WEYHILL CIRCLE – VARIANCE FOR SIDE YARD SETBACK FOR GARAGE AND STORAGE AREA ADDITION (7:24 p.m.)**

Attorney Sarah Murray was present representing the Kelly's. This property is part of a condominium and each unit is allocated a common area which surrounds the building; a single-family home sits on the property which includes a two-bay garage. The Kelly's propose to construct a 120 square foot storage area to the rear of the garage and add a third bay to their garage measuring 336 square feet, so side yard setback relief is needed. The HOA has agreed to this. James Boylan, President of the HOA was present as was Zachary Iricle from Lewis Brothers. Council took no action.

B. **IESI BETHLEHEM LANDFILL – 2335 APPLEBUTTER ROAD – UPDATE ON ACTIVITIES (7:27 p.m.)**

Don Hallock and Nick Rogers from IESI, and Kevin Bodner from Martin and Martin were present. Mrs. Louder said she requested their presence and asked about the sewage sludge. Mr. Taylor answered some of her questions and she understands that IESI has decided to not receive any sewage sludge at this time. Mr. Hallock said that was for the Form-U sent in for that project. They do accept under the profile of sewage sludge, but it's actually 10% sewage sludge and 90% soil. The Form-U was approved in 2016 when they accepted their first load, they accepted 15 loads in the last four months of 2016, and in 2017 they accepted 198 loads.

Mrs. Louder asked what they used it for? Mr. Hallock said it is buried for disposal. In 2017 they had three odor complaints; they had one complaint on the morning of August 31, 2017 but did not receive the sludge until the afternoon, so there's zero correlation. When it comes in, it's buried right away. It's never approved for daily cover material.

Mrs. deLeon said she didn't realize there were different types of sludge. Mr. Kern said it's a big mistake to accept sludge – when not accepting sludge, there was no smell; you can't hide sludge or the odor. Mr. Hallock said they will not accept sludge without the soil mixture. When the customer comes in next time, Mr. Taylor can take some pictures.

Mrs. deLeon said when she looked at the quarterly report, there were different types of sludge. Mr. Hallock said he can research it and will send it to Mrs. Huhn. Mrs. deLeon asked if something

could be put in writing to the Township so we have it on record that it is not their intention to accept this certain type of sludge. Mr. Hallock said they can do that. Mrs. Louder said there were three tractor-trailers in Steel City who were looking for the landfill. Mr. Hallock said they took a wrong turn.

Mrs. Louder asked when the landfill planned to demolish the properties that are becoming blighted along Applebutter Road? Mr. Hallock said fire companies are doing training and they will try to get them all removed by the end of March 2018; he needs to get permits first.

Mr. Matt McClarin, Riverside Drive, said he's been noticing activity on top of the landfill and asked where they stand with finishing the wall. Mr. Taylor said that they were placing garbage at the top of the landfill, but the MSE wall is complete, which on the south side is not visible to Steel City. Disposal activity on top of the landfill will be ongoing for months. Mr. Bodner said the wall is complete and disposal operations will move down when they are complete in the spring.

**C. DISCUSSION ON ADELPHIA GATEWAY PIPELINE (7:47 p.m.)**

Mrs. Yerger said the EAC discussed this – there are no laterals and it's not a new pipeline; it's a conversion of an oil pipeline to gas. According to the owners of Adelfphia, they have done this procedure before and have had no issues. The only thing that came up was that they are increasing the pressure as it's gas and not oil and replacing some pressure valves. They are not digging up any pipelines or increasing the size.

Mrs. deLeon said it already happened in 1996 and Mrs. Yerger said there have not been any detrimental effects as far as we know. Mrs. deLeon said they are going to increase the pressure a lot and the pipes were from the 70's; now that they filed with FERC, we have to talk about if we want to intervene. Since the pipeline is existing what's the safety we have if there's a catastrophic incident or rupture? Do we have a plan in place?

Bryan Evans, Emergency Management Coordinator, said they have an EOP which is meant to be broad and covers anything. They can review the EOP in May and talk with the County, asking them if there is anything specific to pipelines. Mrs. deLeon asked whether any training has been held regarding pipelines? Mr. Evans said they've had multiple trainings by UGI, Columbia Gas and others. He will follow-up to see the last time training was done. Everyone has been very willing to do that and very responsive anytime there is an odor or alarm. Sgt. Thomas Barndt said all police officers in LST have attended pipeline awareness training which is offered twice a year.

Mrs. deLeon would like to know what process they used when they changed from oil to gas. Did they notify the Township? She'd like them to provide an interactive map.

Mr. Stauffer asked if we had a cost or a timeframe for this? Attorney Treadwell recommended to ask Attorney Elliot for a cost and a date and we can bring it back.

**D. APPROVAL OF POLICE CHIEF WAGE AND BENEFIT PACKAGE (8:03 p.m.)**

Mrs. Huhn said this was the topic discussed in Executive Session. The Solicitor will write a contractual letter with the starting salary and benefits, they will pay out the current sick time if Council approves.

and the President of the Lower Saucon Police Association. There were very good candidates, but it became quite apparent that Tom Barndt had the character and traits that were best suited for LST. Sgt. Barndt thanked Council, Mrs. Huhn and the Search Committee for all the time that they put in, and he gladly accepted the offer. He will speak at the swearing in ceremony of his visions for the department.

Mrs. Yerger said the Search Committee performed very well, and she thinks they should be invited to that meeting. Mrs. Huhn said Mr. Scruggs' assistance was instrumental and his participation was invaluable. She will be sending a thank you to the Search Committee.

**E. AUTHORIZE COLLECTION OF 2018 REAL ESTATE TAXES (8:08 p.m.)**

Mr. Stauffer asked what was the usage for the labor attorney? Attorney Treadwell said a question may arise about collective bargaining agreements and there are instances where potential hearings might involve one of the agreements as well. Mr. Stauffer commented on their rate being a bit more than the other attorneys, plus they are also in Harrisburg. Mrs. Huhn said their rate is much less than other labor attorneys and communication is usually by conference call or email.
