<u>CALL TO ORDER:</u> The General Business & Developer meeting of Lower Saucon Township Council was called to order on Wednesday May 4, 2016 at 7:00 p.m., at Lower Saucon Township, 3700 Old Philadelphia Pike, Bethlehem, PA with Mr. Ron Horiszny, presiding.

### III. DEVELOPER ITEMS

## A. THOMAS KAY – 1456 GREENWOOD COURT – REQUEST TO AMEND RECORDED LAND DEVELOPMENT AND EASEMENT AGREEMENTS

Thomas Kay was present and said he is seeking to put a 10x12 structure inside an easement area. An independent site survey Mr. Kay had done shows that the applicable use for that easement agreement would not be impeded. He is seeking to have the easement agreement revised in order to place the structure in that area. Mike Beuke from Boucher and James reviewed the memo submitted to the township in regards to the shed. Mrs. deLeon asked if we were ever asked to do this before. Mr. Horiszny said he didn't recall this coming before them in the past. Mr. Kay said his problem is that the right and left sides of his property are a utility easement. Mrs. deLeon said that when he bought the property he should have been aware of the easement. Mr. Kay said he did not know until after his settlement. Mrs. Yerger said there has been a lot of flooding in that area that has caused multiple problems for homeowners. Christine Haden, 1452 Greenwood Court said she that not only is it beneficial to Mr. Kay, it is something she may want to do as well. Mrs. Yerger said if everyone does it, it becomes a cumulative effect. Council goes by what their engineers and planners recommend.

### A. ZONING HEARING BOARD VARIANCES

## 1. <u>JANET TOWNS - 2236 CHURCH LANE - VARIANCE FOR SIDE YARD SETBACK</u>

Janet Towns said she is looking to put in an accessory structure that is 20'x28' on an existing base. It is going to be 9 feet away from the property line. Mr. Horiszny asked if the neighbor's property backs up right to the red line on the drawing. Attorney Treadwell said it is an empty lot. Council took no action.

### 2. <u>JONATHAN BODNYK - 2145 SPRINGTOWN HILL ROAD - VARIANCE TO</u> CONSTRUCT DWELLING ON LAND - LOCKED PARCEL

Tom Lynch, engineer for Mr. Bodnyk was present. He said the Bodnyks own a parcel of land that is approximately 3.2 acres. It is approximately 300 feet off of Springtown Hill Road and completely landlocked. In the past, an access easement was granted to allow access to the parcel. They would like to construct a house on this property using that

access easement. Attorney Treadwell asked if there is an actual recorded easement. Mr. Lynch said it is noted in the deeds for the two adjacent parcels. It is not in the deed for this property. Council took no action.

## 3. RONALD AND NINA BRACALENTE – 1830 OLD MILL ROAD – REVIEW OF FEMA APPLICATION

Ronald Bracalente said the last time he was at council, they reviewed the expansion of his patio. One of the approvals for variances was to amend the flood plain. The process of this included a letter that had to be submitted by council to FEMA. He provided Hanover Engineering information. A letter was sent back to Chris Garges that had a 2 step process. The mapping changes only pertain to where the patio is. The change in the flood plain can't be seen on the map because of how minor it is.

## 4. PA VENTURE CAPITAL, INC - 3667 ROUTE 378 - LOWER SAUCON AUTHORITY UPDATE ON LOCATION OF BILLBOARD

David Hart, VP of PA Venture Capital, was present and said they were here last month to discuss their plans with the billboard. They have been in touch with Lower Saucon Authority. He worked out a detail with the Authority where their relocated billboard will not have any underground appurtenances or foundations anywhere within the easement. They are intending to only increase the size of the sign by 25% which is per the ordinance. This will allow them to have more clearance and he can move it slightly so it is not directly over the water line. Mrs. deLeon asked who watches to makes sure it is not over the easement. Mr. Hart said it will be over the easement but it won't be over the water line. Mrs. deLeon asked how much over the easement. Mr. Hart said the easement there is 20 feet and the only thing in that easement that the authority has is the water line.

# B. NORTHAMPTON COUNTY EMERGENCY OPERATIONS CENTER REQUEST FOR LETTER RECOGNIZING SE-WY-CO AND SOUTHEASTERN FIRE COMPANIES OPERATING UNDER ONE COMMAND STRUCTURE

Todd Weaver, Acting Director on Northampton County 911 Center, is requesting a letter from Lower Saucon Township stating the Township recognizes that Se-Wy-Co and Southeastern Fire Companies will be operating under one command structure for dispatch purposes. A draft letter has been prepared as a result of the discussion at the Council meeting on April 20<sup>th</sup>. Mrs. deLeon thinks that the letter is good, but she would like some language in there that says Lower Saucon Township didn't lose Steel City along the way. Mr. Johnson said that the county already knows because Chris Snyder was up to see them. Mrs. deLeon said she does not think it is a big deal to include the information about Steel City. Mr. Horiszny said it is not necessary. The letter that they drafted is enough. Mrs. Louder was very skeptical about the number changing, but she has better understanding of it now. Mrs. deLeon said she has a better understanding as well but she does not like their attitudes and she is very disappointed with everyone.

Sal Ghazi, President Se-Wy-Co, said there are still 3 fire companies in the township. Nothing has changed. Unlike when they merged with Leithsville, that is not happening. Last month's meeting ended up being questions about the fire company's budgets which has nothing to do with this. We are not apologizing because we came just for this which is what the township wanted. When Steel City is ready, they will come with us too. The budget is submitted every year and an open forum is not the place to discuss their financials. Mr. Ghazi said they took a lot of heat for what was discussed last meeting.

### C. APPROVAL OF BOOM MOWER REPLACEMENT

Mrs. Huhn said that funding was approved in the 2016 budget from the capital and state funds in the amount of \$130,000. The price quote was \$141,757. If approved, the additional \$11,757 would come from State funding. We would recommend selling the used mower to offset the budgetary overage.

## D. REQUEST FOR BUDGET INCREASE FOR CONSULTANTS REVIEW OF IESI MAJOR PERMIT MODIFICATION

Mrs. Huhn said in March 2015, Council authorized the Landfill Consultants to review the major permit modification application submitted to DEP by IESI. Council approved a budget amount of \$23,600.00. Hanover Engineering has provided an outline of the tasks remaining and is requesting an additional \$5,252.37. This is for reviews and meeting attendance by Hanover Engineering and for \$720.00 for reviews by Rich Sichler of Neversink Environmental.

### E. APPROVAL OF REVISED JOB DESCRIPTION

Mrs. Huhn said we are currently in the process of reviewing employee job descriptions for the Township employees which she will be bringing to Council at a later date. In the interim, she would like to request permission to fill the vacant position previously held by Mrs. Huhn. She has prepared a revised job description that will replace the Assistant Manager position with an Assistant to the Manager. This position will have a focus on Human Recourses and will assist Mrs. Huhn in preparing employee policies and to guarantee these policies are presented to Council on an annual and ongoing basis. The amount budgeted for 2016 for this position was \$66,064.17. Should council approve this request, Mrs. Huhn recommends the salary range for this position be set between \$43,000 and \$46,000 based on experience. This will represent a cost savings for the township of approximately \$20,000. If this is approved, Mrs. Huhn will also bring back to Council a revised organizational chart outlining the chain of command. Mrs. deLeon said that it is well written but it is being compared to the Assistant Manager. However, we aren't really comparing apples to apples. Mrs. Huhn said looking at what we have now with an administrative assistant and

an assistant to the manager, she is reducing the salary. Mrs. Louder thinks it is a good idea to bring on Human Resources.

## F. <u>SAUCON VALLEY COMMUNITY CENTER - APPROVAL OF 2016 SUMMER RECREATION PROGRAMRS.</u>

They operate it during the summer and it will run from June 21<sup>st</sup> to August 12<sup>th</sup> t will be held at Town Hall Park, Southeastern Park and Polk Valley Park. Funding was approved in the 2016 budget in the amount of \$25,871 for the recreation program and \$3,207.92 for the children's program.

## H. RESOLUTION #46-2016 – ADOPTING THE EMERGENCY OPERATIONS PLAN FOR LST

Mr. Horiszny said that the Emergency Management Coordinator, Bryan Evans, has prepared an update to the Township's Emergency Operations Plan (EOP). The PA Emergency Management Services Code mandates that the Township maintain an EOP and Resolution #46-2016 has been prepared to adopt the EOP as revised. Mr. Evans said we always attach the School District and Authority plans to this. Mrs. Huhn said that she believes we added the BRE EOP plan as well. Mr. Evans said this is his first revision and it wasn't in the copy he has. Mrs. deLeon said that should be in there and so should the landfill. Mrs. deLeon said she is disappointed it was not followed up on. She would like the Resolution to revise the plan go to 1 year instead of 2 years. Mr. Evans said while the plan has to be there, it has very little impact and he can't think of one incident in this Township where he would think to pull out the plan and reference it. Mrs. Huhn recommended doing an addendum annually which would include any revisions to contact information instead of a complete plan, since the forms do not change.

### Mrs. deLeon

- She said the DEP letters from the PennEast Pipeline stated their application was incomplete. She asked Mrs. Huhn to forward the letters to FERC.
- She said she asked Mrs. Huhn to put the new Wal-Mart in Southside Bethlehem on the Partnership agenda. Mrs. Yerger said at the planning commission, they did not grant a waiver for LVIP because they do not have enough information.
- She attended Hellertown Historical Society's ribbon cutting ceremony. We were presented with a beautiful print of the mill. There was not a big turnout for history day at the Heller Homestead
- The Hellertown Lower Saucon Chamber is meeting on May 18<sup>th</sup> at 7:30 a.m
- On May 21<sup>st</sup>, the Conservancy is hosting a barn photo shoot workshop with Frank Smith.
- On June 4<sup>th</sup>, the Conservancy is having a Saucon Creek Arts Festival. She received an email that stated Lower Saucon Township was also sponsoring it. She asked Mrs. Huhn to see if she can contact them to see if we are missing something. When she went on the site and clicked to become a sponsor, there is a nature trail sponsor and she didn't think they could do that. Mrs. Huhn will ask them.
- In late 2012 we were asked to give approval for IESI to take Hurricane Sandy waste. Jim Birdsall sent a letter asking the location of where the Sandy waste was dumped. According to DEP, they reported a daily tonnage of 18,559.92 for November and 11,063.33 for December for a total of 29,216.05 tons. She would like Mrs. Huhn to follow up on that letter to see where this waste was dumped.
- We received a report from DEP and they noted they smelled intermittent working face odor on Riverside Drive.
- Mrs. deLeon called the DEP Complaint Line with a complaint of odor. They told her that if it wasn't on your property, you shouldn't be calling. People do not want to call since they don't listen. DEP wants to know no matter what if there is an odor.
- She read something about exempt employees being reclassified. Mrs. Huhn said Mrs. Gorman has been looking in to it and they will follow up with it.
