**Ordinance #2008-09**

**AN ORDINANCE OF LOWER SAUCON TOWNSHIP, NORTHAMPTON COUNTY, PENNSYLVANIA, ENTERING INTO AN AGREEMENT WITH HELLERTOWN BOROUGH AND SAUCON VALLEY SCHOOL DISTRICT RELATED TO THE RESURFACING OF PARKING LOTS AND CAMPUS STREETS ON THE SAUCON VALLEY SCHOOL DISTRICT POLK VALLEY ROAD CAMPUS PURSUANT TO THE INTERGOVERNMENTAL COOPERATION LAW, TITLE 52 Pa. C.S.A. §2301**

**WHEREAS**, the Saucon Valley School District is a third class school district organized and operated under the laws of the Commonwealth of Pennsylvania; and

**WHEREAS**, the Lower Saucon Township is a Township of the Second Class, Optional Plan organized and operating under the laws of the Commonwealth of Pennsylvania; and

**WHEREAS**, the Intergovernmental Cooperation Law allows municipalities to jointly cooperate in the exercise of their respective governmental functions, power, or responsibilities. See Title 53 Pa. C.S.A. §2301 et seq; and

**WHEREAS**, the Saucon Valley School District campus parking lots and roadways are in need of maintenance, resurfacing and repair; and

**WHEREAS**, the Saucon Valley School District Board of Directors, Borough of Hellertown Council and Lower Saucon Township Council recognize that utilization of municipal employees to perform the resurfacing and paving will result in substantial monetary savings; and

**NOW THEREFORE, IT IS HEREBY ENACTED AND ORDAINED**, and it is enacted and ordained by the Council of Lower Saucon Township as follows:

**SECTION I.**

1. All "WHEREAS" clauses are incorporated in this Ordinance as though the same were more fully set forth at length.
2. The Township of Lower Saucon hereby signifies its intention to, and is hereby authorized to enter into an Intergovernmental Agreement with Hellertown Borough and Saucon Valley School District. A copy of said agreement is attached hereto, incorporated herein and made a part hereof as Exhibit "A".

3. The President of Council has authorized and executed the Intergovernmental Agreement on the behalf of Lower Saucon Township.
4. The terms and conditions of the Intergovernmental Agreement with Hellertown Borough and Saucon Valley School District acknowledging the resurfacing of parking lots and campus streets on the Saucon Valley School District Polk Valley Road Campus and which are specifically set forth in the Agreement attached hereto and made a part herein as Exhibit "A".
5. The Township of Lower Saucon, a Township incorporated under the Second Class Township Code, Optional Plan, is empowered to enter into this agreement with Hellertown Borough and Saucon Valley School District.

## **SECTION II. SEVERABILITY**

If any sentence, clause, section or part of this ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any other remaining provisions, sentences, clauses, sections, or parts of this ordinance. It is hereby declared as the intent of the Council of Lower Saucon Township that this ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included therein.

## **SECTION III. REPEALER**

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

## **SECTION IV. EFFECTIVE DATE**

This ordinance will become effective five (5) days after its enactment.
