Enclosed is the renewed Solid Waste Management Permit No. 100020 which the Department is issuing to IESI PA Bethlehem Landfill Corporation, for the continued operation of the IESI PA Bethlehem Landfill. This permit allows IESI to continue to operate this facility per the approved application and terms and conditions of this permit until April 17, 2023.

Chapter 5A, to the Environmental Hearing Board, Second Floor, Rachel Carson State Office Building, 400 Market Street, P.O. Box 8457, Harrisburg, PA 17105-8457. 717-787-3483. Appeals must be filed with the Environmental Hearing Board within 30 days of receipt of written notice of this action unless the appropriate statute provides a different time period. Copies of the appeal form and the Board's rules of practice and procedure may be obtained from the Board. The appeal form and the Board's rules of practice and procedure are also available in Braille or on audiotape from the Secretary to the Board at 717-787-3483. This paragraph does not, in and of itself, create any right of appeal beyond that permitted by applicable statutes and decisional law.

**MODIFICATION TO SOLID WASTE DISPOSAL AND/OR PROCESSING PERMIT**

Under the provisions of Act 97, the Solid Waste Management Act of July 7 1980, Solid Waste Permit Number 100020 issued on (date original permit was issued) June 29, 1990 to (permittee) IESI PA Bethlehem Landfill Corporation (address) 2335 Applebutter Road  
Bethlehem, PA 18015

is hereby modified as follows:

The permit renewal requested on July 6, 2012, is approved subject to the following conditions:

1. This permit renewal approves the application received on July 6, 2012. The original permit renewal application was prepared by Martin and Martin, Inc., 37 South Main Street, Suite A, Chambersburg, PA 17201. The application included the following:
  - a. Narrative, including Bonding Worksheet L, dated June 2012;
  - b. Form GIF, signed on 6/20/2012;
  - c. Form A, signed on 7/3/2012;
  - d. Form B, signed on 6/27/2012;
  - e. Form B1, signed on 6/27/12;
  - f. Form C1, signed on 6/27/12;
  - g. Form 46, dated 7/5/12.
2. This approval extends the permit term of the IESI PA Bethlehem Landfill Corporation. The permit expires on April 17, 2023.
3. Based on a June 24, 2012 survey, the remaining landfill capacity is 2,175,000 cubic yards. The permit will not be renewed prior to the expiration date of the fixed term. Increases in waste capacity identified in this condition will require a major permit modification in accordance with 25 Pa Code §271.144.

This modification shall be attached to the existing Solid Waste Permit described above and shall become a part thereof effective on
