Saucon Valley Proud Congratulations to our Hometown Heroes!



Saucon Valley Graduate and Lower Saucon resident Talitha Diggs recently won the 400m race at the 2022 USA Outdoor Track and Field Championships to qualify for the 2022 World Athletics Championships held in Eugene, Oregon.

Prior to this, Talitha won the 2022 NCAA Outdoor Championship and NCAA Indoor Championship representing the University of Florida. She is the second woman in NCAA history to win the USA Championships, NCAA Outdoor and NCAA Indoor Championships in the same season. She is the 5th fastest collegiate 400m runner in history having run 49.99 to win the NCAA Outdoor Championships. *All of Talitha's accomplishments and full bio can be found on the Florida Gators website: <https://floridagators.com/>.*

Talitha also holds the PIAA State outdoor 400 meter record (52.82 seconds) which she set in May, 2019. Coach Ed Kolosky said that this record is also an amazing milestone in Talitha's career.

The 2022 Saucon Valley Baseball Team recently completed a 20-4 season. This matches the school record for most wins in a season. The Panthers earned a District XI Championship by defeating Blue Mt. 5-2 and played their way to the State Quarterfinals before falling to Holy Ghost Prep 6-1. Coach Laub said the Comeback Kids will return with six starters next year and hopes to build onto this historic season.

PROJECT LIFESAVER PROGRAM



The Lower Saucon Police Department is proud to offer the Project Lifesaver Program. Project Lifesaver is the premier search and rescue program operated internationally by public safety agencies and is strategically designed for “at risk” individuals who are prone to the life threatening behavior of wandering. The primary mission of Project Lifesaver is to provide timely response to save lives and reduce potential injury for adults and children with the propensity to wander due to a cognitive condition.

Project Lifesaver was the first to apply such locating techniques to aid in the search and rescue of individuals. The program is the most widely used and is proven the most effective in the nation that is specifically designed to protect the “at risk” populations in our communities. The program was structured in a way that strategically combined state of the art locating technologies, innovative search and rescue methods, and community policing courses that educated first responders about cognitive conditions. The search times for certified Project Lifesaver agencies have been reduced from hours, potentially days, down to minutes. Recovery times for Project Lifesaver agencies average 30 minutes, which is 95% less time than standard operations without Project Lifesaver.

The method relies on proven radio technology and specifically trained search and rescue teams. Citizens enrolled in Project Lifesaver wear a small transmitter on the wrist or ankle that emits and individualized frequency signal. If an enrolled client goes missing, the caregiver notifies their local Project Lifesaver agency, and a trained emergency team responds to the wanderer’s area. The first responders will then use the client’s individualized frequency to locate the position of the individual. The knowledge given from the community policing courses is best applied in this situation because the first responders will know how to best approach the client once found, and allow them to be brought back to safety.

Home First Survival

(First In A Series)

The best way to survive a fire catastrophe at home is PREPARATION. Every second of early warning is paramount. Preparation's first step is planning. But, before we get into that, let's talk at length about "Fire Detection". There are some things you should know about smoke detectors in order to make an informed decision on what type you may want to use and their locations.

There are three basic types of home smoke detectors: Ionization, Photoelectric, and dual sensor units that combine both technologies. These smoke detectors sense the presence of smoke in two different and distinctive ways:

The type of smoke produced by a fire depends on the type of fire. Flaming fires produce a different type of smoke than a smoldering fire. Both smoke detectors will detect smoke from either type of fire.

Types of Smoke Detector Sensors:

- **Ionization** smoke detectors tend to respond faster to the smoke produced by flaming fires. The sensor contains a small amount of radioactive material between two charged plates, creating an electric charge through the plates. When smoke gets inside the sensor, it disrupts the electrical current which activates the alarm.
- **Photoelectric** smoke detectors tend to respond faster to the smoke produced by smoldering fires. The sensor produces an angled beam of light into a sensing chamber within the detector. When smoke enters the chamber, it disrupts the light beam and reflects it onto a nearby sensor activating the alarm.

Because both ionization and photoelectric smoke alarms are better at detecting distinctively different yet potentially fatal fires, and because no one can predict what type of fire might start in a home, it is recommended that both types be used or dual sensor alarms containing both types be used.

The location of a smoke detector within a home may be more important than the type of detector. It is important that the home owner follows the manufacturer's recommendations for locations.

As a side note, the standards for UL certification were scheduled to be updated in June, 2022 and will prohibit manufacturers from producing swindler-sensor smoke detectors— which is even more reason to consider a dual-sensor unit.

Installing Smoke Detectors:

The National Fire Protection Association recommends using smoke detectors having the label of a recognized testing laboratory. They should be installed in the following locations:

- Inside each bedroom, outside each sleeping area, and on every level of the home, including the basement.
- On levels without bedrooms, install detectors in the living room (or den or family room) or near the stairway to the upper level, or in both locations.
- Smoke detectors installed in the basement should be installed on the ceiling at the bottom of the stairs leading to the next level.
- Smoke detectors should be installed at least 10 feet from a cooking appliance to minimize false alarms when cooking.
- Mount smoke detectors high on walls or ceilings (remember, smoke rises). Wall mounted detectors should be installed not more than 12 inches from the ceiling to the top of the detector.
- If you have ceilings that are pitched, install the detector within 3 feet of the peak but not within the apex of the peak (four inches down from the peak).
- **NEVER PAINT SMOKE DETECTORS OR HIDE THEM WITH DECORATIONS.**
- For the best protection, interconnect all smoke detectors so that when one detector goes into alarm, they all will sound. The interconnection can be done using "hard-wiring" or wireless technology.

Testing Smoke Detectors:

- Test smoke alarms at least once a month using the test button.
- Make sure everyone in the home understands the sound of the smoke alarm and knows how to respond.
- Follow the manufacturer's instruction for maintenance and cleaning.

Today's new smoke detectors are designed to last ten years without battery replacement. If it begins to "chirp", replace the entire unit. Older smoke detectors with any other type of battery, need a new battery once a year. If that detector begins to "chirp", replace the battery right away.

- When replacing a battery, follow the manufacturer's list of batteries on the back of the detector or listed in the instructions. Manufacturer's instructions are specific to the batteries (brand and model) that must be used. The smoke detector may not work properly if a different type of battery is used.

Smart Features:

A lot of smoke detectors today come with smart features. This new type of smoke detector can connect to your smartphone, automatically update you of the detector's status and battery level, and be operated directly from your smart devices. New smoke detectors can be connected in a network so they all go off at the same time, and some even allow you to directly connect them to the 911 center.

Multiple Functionality:

Many smoke detectors do double duty and function as carbon monoxide (CO) detectors as well. Since fires also create elevated levels of CO, this can also be an early warning device. This is especially true when they are installed in areas where gas furnaces and water heaters are operating. If there is a malfunction in the combustion process, they generally will emit elevated levels of carbon monoxide. And since CO is both odorless and invisible, it can be fatal without early detection.

Finally, to those who are considering the purchase of a home, make sure your home inspection includes adequate and functional smoke detectors. If you are considering the purchase of a home security system, why not include a smoke detection system as well?

Some Food for Thought:

If you have a family with young children, do they stay overnight for a sleepover at their friend's house? Do you know if that home has adequate fire detection? Also do they have an evacuation plan that your child is familiar with? Think about it.

LIHWAP may be able to assist you with overdue water and wastewater bills.

The Lower Saucon Authority has signed up with the PA Department of Human Services to take part in the Low-Income Household Water Assistance Program. LIHWAP is a new, temporary assistance program created by the American Rescue Plan Act in 2021.

LIHWAP can help households that are in emergency situations maintain essential water access.

What is LIHWAP?

The Low Income Household Water Assistance Program (LIHWAP) is a temporary emergency program to help low income families pay overdue water bills. LIHWAP is a grant. You do not have to repay it.

To receive help...

- Apply starting January 4, 2022.
- You don't have to be on public assistance.
- You need to have an unpaid water bill.
- You can either rent or own your home.

How does LIHWAP work?

LIHWAP Crisis grants may be available if you have an emergency situation and are in jeopardy of losing your water service. You can receive one Crisis grant for your drinking water service and one Crisis grant for your wastewater service, up to \$2,500 each.

Crisis situations include:

- Past-due water bills
- Termination of utility service
- Danger of having utility service terminated (received a notice that service will be shut off within the next 60 days.)

How do I apply?

- Apply online at www.compass.state.pa.us.
- Request an application by calling the Statewide Customer Service Center at 877-395-8930 or call PA Relay at 711 for the hearing impaired
- Applications are also available at your local county assistance office.

To apply, you will need:

- Names of people in your household
- Dates of birth for all household members
- Social Security numbers for all household members
- Proof of income for all household members; and
- A recent water bill.

Who is eligible?

You may qualify for a LIHWAP grant if:

- You must have an overdue water bill that you are responsible for paying.
- Your household income must meet the following income guidelines —>

After your application is processed, you will receive a written notice that will tell you if you qualify. If eligible, it will tell you the amount of your grant.


