#### ERA: Section 1, Article 27


"The people have a right to clean air, pure water, and to the preservation of the natural, scenic, historic, and esthetic values of the environment. Pennsylvania's public natural resources are the common property of all the people, including generations yet to come. As trustee of these resources, the commonwealth shall conserve and maintain them for the benefit of all the people."



### EJ Definition (PADEP)

Environmental justice means the just treatment and meaningful involvement of all people, regardless of income, wealth, race, color, national origin, area of residence, Tribal affiliation, or disability, in agency decision-making and other activities that affect human health and the environment so that people: are fully protected from disproportionate and adverse human health and environmental effects (including risks) and hazards, including those related to climate change, the cumulative impacts of environmental and other burdens, and the legacy of racism or other structural or systemic barriers; and have equitable access to a healthy, sustainable, and resilient environment in which to live, play, work, learn, grow, worship, and engage in cultural and subsistence practices. It further involves the prevention of future environmental injustice and the redress of historic environmental injustice.

#### **Definitions of Environmental Justice**

#### U.S. EPA

Fair treatment and meaningful involvement of all people, regardless of race, color, national origin or income, in the development, implementation and enforcement of environmental laws, regulations and policies.

#### Pennsylvania DEP

Environmental justice embodies the principle that communities and populations should not be disproportionally exposed to adverse environmental impacts.



# Roots of EJ in Pennsylvania

- Organizing of Chester in early 1990s
- Environmental Risk Study by EPA in conjunction with DER in 1993
- Chester residents (CRCQL) lawsuit against DEP in 1996
- DEP Environmental Justice Work Group (EJWG) created in 1999 Report and Recommendations released in 2001



### Timeline of Federal and State Government Response



#### **OEJ Goals**

- Minimizing Adverse Environmental Impacts All communities are not unjustly and/or disproportionally burdened with adverse environmental impacts
- Empowering Communities Ensuring citizens have meaningful involvement and a voice in decision-making process
- Fostering Economic Opportunities Enable environmentally responsible economic development to and within EJ communities and in some cases build collaborations and relationships with the community and industry



#### 2021 EJ Executive Order

- An <u>Executive Order</u> on environmental justice was issued on October 28, 2021.
- Permanently established the Office of Environmental Justice.
- Formally established the Environmental Justice Advisory Board
- Created an Environmental Justice Interagency Council
- Outlined activities that executive branch agencies should take to further environmental justice goals.





# Purpose of EJ Policy Updates

- Withdrew a draft Policy because it solely focused on public engagement in the permitting process and did not address wider concerns.
- How can DEP address EJ in addition to public participation in the permit review process?
- Focused on incorporating a meaningful community engagement process to ensure inclusive community voice around its creation.
- Center this discussion on the voices of those who live in communities facing environmental burdens.



#### **2004 EJ Policy**


- Defined Environmental Justice area based on two demographic factors, poverty and race.

#### **Indicator Categories**

#### **Pollution Burden** (Threat)

- Environmental exposures: quantifiable levels of pollutants
- **Environmental effects**: adverse environmental conditions / risks that are not quantifiable
  - Based on proximity

#### **Population Characteristics** (Vulnerability)

- Sensitive Populations: health characteristics that either amplify or may be caused by environmental hazards
- Socioeconomic factors: certain demographic characteristics may reduce communities' ability to mitigate effects of environmental hazards



# Calculating Final Score

$$C = \frac{\sum c}{n}$$

C= Component score

 $\Sigma C$  = Sum of all indicator percentiles within component

n = Number of indicators within component

$$PB = \frac{\text{EXP}_{avg} + (\text{EE}_{avg} \times 0.5)}{1.5}$$

PB = Pollution Burden score

EXP = Environmental Exposures component score (average of all Environmental Exposures indicators)

EE = Environmental Effects component score (average of all Environmental Effects indicators)

$$PC = \frac{SOC_{avg} + SP_{avg}}{2}$$

PC = Population Characteristics score

SOC = Socioeconomic Populations component score (average of all Socioeconomic Populations indicators)

SP = Sensitive Populations component score (average of all Sensitive Populations indicators)






#### PennEnviroScreen – EJ Areas

#### **Community Change Grant**

#### **Background:**

- EPA received \$3 billion through the Inflation Reduction Act (IRA) to fund environmental and climate justice activities to benefit disadvantaged communities.
- All grants must be awarded by September 30, 2026.

#### Goals:

- Fund community-driven pollution and climate resiliency solutions.
- Invest in strong cross-sectoral collaborations with partners working with and for communities.
- Unlock access to more significant resources.
- Deliver technical assistance and capacity-building support.
- Strengthen communities' decision-making power.

#### **Details:**

- Track I: Community-Driven Investments for Change
  - Per Award Amount: \$10M and cannot exceed \$20M each
- Track 2: Meaningful Engagement for Equitable Governance
  - Per Award Amount: \$1M and cannot exceed \$3M each

#### **Technical Assistance**

- Community Change Technical Assistance Program
- Equitable Resilience Technical Assistance Program
- Thriving Communities Technical Assistance Centers (TCTACs)
